polemics and reflections on how to bridge the gap between what architecture actually is and what architects want it to be architecture depends on what on people time politics ethics mess the real world architecture jeremy till argues with conviction in this engaging sometimes pugnacious book cannot help itself it is dependent for its very existence on things outside itself despite the claims of autonomy purity and control that architects like to make about their practice architecture is buffeted by uncertainty and contingency circumstances invariably intervene to upset the architect's best laid plans at every stage in the process from design through construction to occupancy architects however tend to deny this fearing contingency and preferring to pursue perfection with architecture depends architect and critic jeremy till offers a proposal for rescuing architects from themselves a way to bridge the gap between what architecture actually is and what architects want it to be mixing anecdote design social theory and personal experience till's writing is always accessible moving freely between high and low registers much like his suggestions for architecture itself

shortlisted for the architectural book awards 2024 thinking through twentieth century architecture connects the practice of architecture with its recent history and its theoretical origins those philosophical ideas that lay behind modernism and its aftermath by analyzing in

straightforward and jargon free language the genesis of modernism and the complex reactions to it the book clarifies a continuing debate it has been specifically written to connect issues of theory history and contemporary practice and to allow students to make these connections easily this is a history of twentieth century architecture written with close critical attention to the theories that lie behind the works described importantly unlike other historical accounts it does not take sides and urge the reader to identify with one strand of thinking or style of architecture at the expense of others but it presents a dispassionate view with persuasive arguments on behalf of different positions it pursues the history of european and american architecture chronologically but the history is interwoven with the philosophical ideas that informed both writers and architects and are essential for its understanding the book is relevant to current issues of contemporary practice and education showing that philosophical issues are fundamental and those relating to design decisions never go away it includes 200 illustrations and will appeal to all those interested in twentieth century architecture and to architectural students

care and design bodies buildings cities connects the study of design with care and explores how concepts of care may have relevance for the ways in which urban environments are designed it explores how practices and spaces of care are sustained specifically in urban settings thereby throwing light on an important arena of care that current work has rarely discussed in detail

as with so many facets of contemporary western life architecture and space are often experienced and understood as a commodity or product the premise of this book is to offer alternatives to the practices and values of such westernised space and architecture with a capital a by exploring the participatory and grass roots practices used in alternative development models in the global south this process re

contextualises the spaces values and relationships produced by such alternative methods of development and social agency it asks whether such spatial practices provide concrete realisations of some key concepts of western spatial theory questioning whether we might challenge the space and architectures of capitalist development by learning from the places and practices of others exploring these themes offers a critical examination of alternative development practices methods in the global south re contextualising them as architectural engagements with socio political space the comparison of such interdisciplinary contexts and discourses reveals the political social and economic resonances inherent between these previously unconnected spatial protagonists the interdependence of spatial issues of choice value and identity are revealed through a comparative study of the discourses of henri lefebvre john turner doreen massey and nabeel hamdi these key protagonists offer a critical framework of discourses from which further connections to socio spatial discourses and concepts are made including post marxist theory orientalism post structural pluralism development anthropology post colonial theory hybridity difference and subalterneity by looking to the spaces and practices of alternative development in the global south this book offers a critical reflection upon the working practices of westernised architecture and other spatial and political practices in exploring the methodologies implications and values of such participatory development practices this book ultimately seeks to articulate the positive potential and political of learning from the difference multiplicity and otherness of development practice in order to re imagine architecture and space

this book is motivated by a simple observation privately owned public spaces or pops are overlooked sites when it comes to exploring the subject of taste in architecture and urban design the book unpacks the intricate world that unfolds from this thought while arguing that taste

is a missing key in current spatial practice discourse successful pops are often presented as desirable additions to urban redevelopment projects in cities across the world this perception often overshadows and sometimes dismisses some of the more damaging impacts that the establishment of pops has on the social tissue of specific localities and social groups and more generally on the socio political dynamics of cities within the fields of architecture and urban design high regard for specific urban regeneration projects with pops at their heart tends to ignore their inherently divisive social impact this in turn strengthens an often legitimised belief that analysing questioning and re aligning such impact falls outside the realm of these professions this book explores how successful pops are sustained through among other maintenance practices carefully managed aesthetic codes largely dependent on showcasing the aesthetic value of highly controlled programmes of use this specific practice turns pops into revealing sites when it comes to exploring taste in the context of spatial practice why don t we talk about taste in socially engaged practice today does a focus on aesthetics pose an ethical dilemma between superficiality and depth for practitioners in the face of persistent social inequity

vivian manasc one of the founders of manasc isaac architects has pioneered sustainable architecture in canada her work in partnership with indigenous communities has been her greatest inspiration and it has transformed the very nature of her practice through the profound lessons of the seven grandfather teachings vivian came to understand that the process of planning and designing a building should be a circle with the beginning and end of the story linked together the stories vivian tells in old stories new ways are also framed by these teachings of courage love wisdom respect truth humility and honesty with each teaching illuminating an aspect of how working with dene cree saulteaux métis inuit and inuvialuit communities has influenced her design practice
