further explain the motivations behind the adoption of offshore outsourcing the study illustrates that achieving successful outcomes from offshore outsourcing activities critically depends on the organisation adequately addressing a number of factors such as conveying a sense of urgency developing and communicating the vision identifying the benefits of change and how they will be delivered generating short term wins providing education and training developing a fit between the change and organisational culture etc throughout the change process the findings also highlight the effects of offshore outsourcing on the case organisations including change in job roles and responsibilities and organisational learning activities that enable corrective actions to improve change management efforts an important contribution of this research is the development of a model providing a more comprehensive understanding of the change process associated with the implementation of offshore it outsourcing recommendations for policy makers and change managers to improve change management practice based on the research findings as well as recommendations for further research form a significant part of the conclusions
