ACCURAL ACCOUNTING THIS PRINCIPLE RECOGNIZES REVENUE WHEN EARNED AND EXPENSES WHEN INCURRED REGARDLESS OF WHEN CASH IS EXCHANGED

THIS PROVIDES A MORE ACCURATE PICTURE OF A COMPANY'S PERFORMANCE OVER TIME

MATCHING PRINCIPLE THIS PRINCIPLE STATES THAT EXPENSES SHOULD BE MATCHED WITH THE REVENUES THEY HELPED GENERATE WITHIN THE SAME ACCOUNTING PERIOD

MATERIALITY THIS PRINCIPLE FOCUSES ON REPORTING INFORMATION THAT IS SIGNIFICANT ENOUGH TO INFLUENCE THE DECISIONS OF USERS OF FINANCIAL STATEMENTS

CONSISTENCY A COMPANY SHOULD USE THE SAME ACCOUNTING METHODS FROM PERIOD TO PERIOD FOR CONSISTENCY AND COMPARABILITY

FULL DISCLOSURE FINANCIAL STATEMENTS SHOULD INCLUDE ALL RELEVANT INFORMATION THAT COULD IMPACT THE USERS UNDERSTANDING OF THE COMPANY'S FINANCIAL POSITION

THE ESSENTIAL COMPONENTS BUILDING BLOCKS OF FINANCIAL REPORTING FINANCIAL STATEMENTS ARE THE MAIN OUTPUT OF THE ACCOUNTING PROCESS

THEY PROVIDE A COMPREHENSIVE OVERVIEW OF A COMPANY'S FINANCIAL PERFORMANCE AND POSITION

THE CORE COMPONENTS OF THESE STATEMENTS INCLUDE BALANCE SHEET THIS STATEMENT PRESENTS A COMPANY'S ASSETS LIABILITIES AND EQUITY AT A SPECIFIC POINT IN TIME PROVIDING A SNAPSHOT OF ITS FINANCIAL HEALTH

2 ASSETS RESOURCES CONTROLLED BY THE COMPANY THAT ARE EXPECTED TO PROVIDE FUTURE ECONOMIC BENEFITS

EXAMPLES INCLUDE CASH ACCOUNTS RECEIVABLE AND EQUIPMENT

LIABILITIES OBLIGATIONS OF THE COMPANY THAT RESULT FROM PAST TRANSACTIONS AND REQUIRE THE FUTURE TRANSFER OF ASSETS OR PROVISION OF SERVICES

REVENUE INFLOWS OF ECONOMIC BENEFITS THAT ARISE FROM THE ORDINARY ACTIVITIES OF THE COMPANY

EXPENSES OUTFLOWS OF ECONOMIC BENEFITS THAT ARISE FROM THE ORDINARY ACTIVITIES OF THE COMPANY

STATEMENT OF CASH FLOWS THIS STATEMENT TRACKS THE MOVEMENT OF CASH WITHIN A COMPANY OVER A SPECIFIC PERIOD PROVIDING INSIGHTS INTO ITS CASH FLOW SOURCES AND USES

OPERATING ACTIVITIES CASH FLOWS ARISING FROM THE COMPANY'S PRIMARY BUSINESS OPERATIONS

INVESTING ACTIVITIES CASH FLOWS RELATED TO THE ACQUISITION OR DISPOSAL OF LONGTERM ASSETS

FINANCING ACTIVITIES CASH FLOWS RELATED TO DEBT AND EQUITY FINANCING SUCH AS ISSUING NEW SHARES OR REPAYING LOANS


